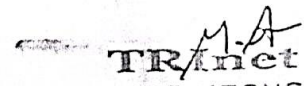

(III) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS

1. PRESIDENT

2. VICE PRESIDENT

3. SECRETARY

4. JOINT SECRETARY

5. TREASURER

He is responsible for all financial transactions and of the Society. He has to maintain accounts properly along with the voucher. He has to prepare the accounts of the Society jointly with the Secretary or President.

6. OFFICE BEARERS

They are responsible persons to attend to such activities of the Society which the Executive Committee entrust to them.

7. QUORUM

Half of the total members for General Body meeting $\frac{1}{4}$ for Executive Committee meeting.

8. FUNDS

The funds shall be sent only for the attachment of the object of the Society and no portion there shall be paid or transferred directly to any of the members through any means.

9. AMENDMENTS

No amendments or alteration shall be made in the purpose of the Association unless it is voted by $\frac{2}{3}$ of its members present at a special meeting convened for the purpose and confirmed by $\frac{2}{3}$ of the members present at a second special meeting.

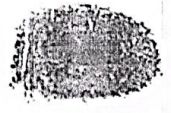
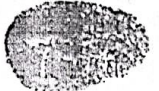
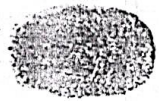
10. WINDING UP
